

PŪRANGI KIWI PROJECT PHOTO COMPETITION

RULES AND ELIGIBILITY

ENTRY ACCEPTANCE OF THESE TERMS AND CONDITIONS:

Submission of photos in the Pūrangi Kiwi Project Photo Competition (“the Competition”) is deemed acceptance of these terms and conditions (“Terms and Conditions”).

1. **PROMOTER:** The Promoter is East Taranaki Environment Trust, (herein referred to as “Pūrangi Kiwi Project”).
2. **ELIGIBILITY:** The competition is open to anyone who submits photo’s taken on either of the two project walkways: *Otunahe Scenic Walkway* and *Hidden Valley Walkway* located at Aukawa Road, Purangi. Entrants may submit up to two photo’s per category. All photo’s submitted must have been taken on the project walkways.
3. **HOW TO ENTER:** Submit a photo for entry in the competition by 5pm 31st January 2019 to info@purangikiwi.co.nz

Photo’s must be submitted to one of the categories: 1. Flora and Fauna

2. People getting back to nature. Entrants may submit two photo’s per category. Please indicate on your email the following information:

1. Your First and Last name (Matching your bank deposit reference)
2. Category you are entering
3. Your contact daytime phone number

Entry is \$10 per photo submitted, in lieu of a walkway donation.

Payment is to be made into the East Taranaki Environment Trust bank account: TSB: 153947 0463618 00. Use your FIRST and LAST name as reference.

Photo’s will be accepted as submitted once payment has been received.

4. **PHOTO SUBMISSION PERIOD:** The competition will run 1st January until 5pm 31st January 2019.
5. **PHOTO REQUIREMENTS:** The photo(s) must meet reasonable standards of decency.
6. **NUMBER OF ENTRIES:** You may submit two photo’s per category during the Photo Submission Period. Only one photo is eligible to win per category.
7. **HOW TO WIN:** One photograph per category will be selected by the Judges as the category winner.

8. **COMPETITION PERIOD:** The competition will be open for the month of January 2019, with entries beginning on the first day of the month and finishing at 5pm (NZST) on the last day of the month.

9. **JUDGING:** Judges will select one winning photo from each of the two categories: (1) Flora and Fauna and (2) People getting back to nature. The judges' decision will be final and no correspondence will be entered into.

10. **PHOTO WINNER NOTIFICATION:** The photo winner will be announced after the closing date and winner will be notified using the contact details provided on their registration within ten days of the announcement.

11. **PRIZE:** The winners of category 1 and 2 will receive a special invitation for up to 2 people to attend a future kiwi release experience. Kiwi release dates are subject to change and will be confirmed with the winners. Prize winners can nominate another person to attend on their behalf if they are unable to attend on the specified date.

The Kiwi Release Experience will be governed by the approved best practice kiwi handling protocols.

12. **ANNOUNCEMENTS:** By submitting a photo for entry, each entrant hereby agrees to participate in any publicity related to the competition. Entrants and winners in the competition agree that their identity may be disclosed in winner announcements and promotional material. Winners also agree to have his/her image used for publicity purposes without any additional payment being made.

13. **PRIZE ELIGIBILITY:** Pūrangi Kiwi Project cannot be held responsible for the winner being unable to redeem their prize.

14. **PHOTO USAGE:** By submitting a photo, the entrant agrees to allow Pūrangi Kiwi Project permission to use the image for the purposes of promoting Pūrangi Kiwi Project or the Competition, now and into the future, at no cost to Pūrangi Kiwi Project. The entrant also agrees to allow Pūrangi Kiwi Project to use their photo for printed collateral, online, in store and across other marketing mediums, at Pūrangi Kiwi Project's sole discretion and at no cost.

15. **PHOTO TALENT:** By submitting the photo, the entrant declares that they have the permission of all individual(s) captured in photo(s) to share and publish their image.

16. **PHOTO COPYRIGHT:** In submitting a photo for entry, the entrant declares that they have taken the photo and own and have sole and complete intellectual property rights to the photo. The entrant will indemnify Pūrangi Kiwi Project against any claim, loss or costs incurred by Pūrangi Kiwi Project where a third party claims ownership of the rights to a photo.

17. **PHOTO USAGE ON SOCIAL MEDIA:** By entering this contest you agree to release any social media entity i.e Facebook/Twitter/instagram or other social media entity of any liability or obligation related to the entry and you acknowledge the promotion is in no way sponsored, endorsed or administered by, or associated with the social media entity where the photo's are posted.

18. **CONTRACT LAW:** All agreements and contracts shall be subject solely to New Zealand law and the exclusive jurisdiction of the New Zealand courts.

19. **ENTRY FORMAT:** Acceptable entries will be photo files from either digital cameras or smart phone cameras or electronic scans. No images supplied in hard copy will be accepted.

20. **ACKNOWLEDGEMENTS:** Entries may not be acknowledged or returned. Participants have the obligation to ensure entries are received on time.

21. **PERSONAL INFORMATION:** The collection, use and disclosure of personal information provided in connection with this competition is governed by the Privacy Laws of New Zealand. Your personal information shall not be provided to any third parties without your prior consent but you do authorise Pūrangi Kiwi Project to be able to contact you with information pertaining to the competition or related promotions.
